

Office Memorandum

Sub: Induction of Driver (Non-Technical) into Technical side (Support Staff) in Group II under Revised MANAS.

On the basis of trade test conducted by the Committee constituted by the Director, CGCRI, Kolkata and subsequent recommendations of the committee on 14.08.2001, the Director, CGCRI has been pleased to approve the induction of Shri B P Singh, Driver, CGCRI Extension Centre, Khurja into Technical Cadre Group II(2) in the scale of Rs. 4500-125-7000/- wef 21.09.2001 under Revised MANAS.

Consequent on his induction into Technical side in Group II he will be eligible for all service benefits as admissible in cases of all other technical personnel in his cadre. The period of service for his assessment to the next higher grade will be counted from the date of his induction into technical stream accordingly.

Further, on vacation of the post by the individual concerned due to resignation, retirements, death etc. the vacancy will occur and be filled up in the non-technical cadre only as per provisions of induction rules.

The pay of Shri Singh will be fixed as per rules i.e. at the same stage and if there is no such stage then at the next higher stage, without giving the benefit of fixation under FR 22(1)(i). Other terms & conditions of his service will remain unchanged.


