Weight of each platinum ingot: 1500 g \pm 150.00 g each (Maximum two numbers of ingot to be supplied)

Purity: **99.99%** (Total metallic impurities including Rh, Fe, Cu, Mo, Ag, Ni should not exceed 100 ppm)

Purity certificate from the manufacturer should be provided.

Purity certificate should meet the desired purity of the supplied items.

GEM REGISTRATION IS MANDATORY.

NOTE TO BIDDERS: GEM REGISTRATION :-
