**OFFICE MEMORANDUM**

**Sub: Agreement with MEDINOVA DIAGNOSTIC SERVICES LTD, KOLKATA for providing medical diagnostic investigation/procedures facilities to employee(s) and registered pensioners.**

It is notified for information of all concerned that **CSIR-CGCRI, KOLKATA and MEDINOVA DIAGNOSTIC SERVICES LTD, KOLKATA** have reached an agreement on 07.12.2022 for providing diagnostic investigation/procedures facilities to the employees/pensioners registered in CSIR Medical Scheme and their valid dependent family members for all medical disciplines available **at CGHS rates except EYE and ENT discipline**. The validity of the aforesaid agreement is for a period of Two (2) years i.e. **07.12.2023 to 06.12.2025**. The details are given below: -

**1, FOR REGULAR STAFF:**

1.1 All radiological & pathological diagnostic investigation/procedures except for EYE and ENT discipline respectively on "CASHLESS CREDIT BASIS" AT CGHS- NABL.

**2. FOR PENSIONERS:**

**1.1 MEDINOVA DIAGNOSTIC SERVICES LTD, KOLKATA** will provide all radiological & pathological diagnostic investigation/procedures except for EYE and ENT discipline respectively at CGHS-2014 NABL rates applicable for KOLKATA updated on 03.05.2021 and revised time to time on "Cash payment basis" which is NOT REIMBURSABLE.

**\*\* GENERAL TERMS\*\***

1.1 **MEDINOVA DIAGNOSTIC SERVICES LTD** will not charge CSIR-CGCRI staff/patient party any service charge, registration charges & medical record charges

1.2 **MEDINOVA DIAGNOSTIC SERVICES LTD, KOLKATA** has agreed to provide **20% Discount** on Non-CGHS procedures/investigations to staff/ pensioners and their valid dependents on prevailing Medinova tariffs.

1.3 **MEDINOVA DIAGNOSTIC SERVICES LTD** has agreed to provide home collection of Blood samples/Urine etc except Radiology for NON-COVID items with the following charges: -

Distance Range	Amount per trip
0 to 1 km	Rs.20/-
1 km to 3 km	Rs.30/-
4km to 8km	Rs.60/-
8km to 10km	Rs.100/-
11km to 15km	Rs.120/-
16km to 25kmn	Ra.150/-
16km to 25km (above)	Rs.200/- to Rs.300/-

1.4 **MEDINOVA DIAGNOSTIC SERVICES LTD** will recover all Non-reimbursable charges which shall be payable in CASH by pensioners of CSIR-CGCRI, Kolkata.

1.5 **MEDINOVA DIAGNOSTIC SERVICES LTD, KOLKATA** has agreed to provide COVID-19 test (Through RT-PCR method and TRUENT method at prevalent rate of CGHS Kolkata or as per the guidelines of the Govt. of West Bengal per test, which is lower) on cash payment basis. Additionally, for Home Collection Rs.200/- will be charged extra and will have to be paid to Medinova Diagnostics services representative in CASH.

Note: **All staff members & pensioners may keep in mind that cashless credit treatment "per se" is not totally free treatment.**

Accordingly, CSIR-CGCRI employee(s) and pensioners registered in CSIR Pensioners medical scheme may avail medical treatments from MEDINOVA DIAGNOSTIC SERVICES LTD, KOLKATA as mentioned hereinbefore.
