OFFICE MEMORANDUM

Sub: Agreement between CSIR-CGCRI and B.P. PODDAR HOSPITAL & MEDICAL RESEARCH LTD., KOLKATA for providing medical treatments to employees/ registered pensioners and their valid dependants

It is notified for information of all concerned that CSIR-CGCRI, KOLKATA and B. P. PODDAR HOSPITAL & MEDICAL RESEARCH LTD., 71/1 Humayun Kabir Sarani, New Alipore, Block-G, Kolkata-700053 have reached an agreement on 20-12-2021 for providing Out-patient Department (OPD) and In-Patient Department (IPD) medical treatments to the employees/pensioners registered in CSIR Medical Scheme and their valid dependants for all medical disciplines available in the hospital. The validity of the aforesaid agreement is for a period of two (2) years i.e. from **20.12.2021 to 19.12.2023**. Details are furnished below:

1. FOR REGULAR STAFF [OPD TREATMENT]

1.1 Regular staff members and their valid dependants may avail OPD treatments, including investigation, Day Care treatments in B.P. Poddar Hospital & Medical Research Ltd., Kolkata at CGHS NABH accredited rates-2021 for Kolkata, extra rates as updated on 03.05.2021 for both procedures and investigations on '**CASH PAYMENT BASIS**'

1.2 The consultation rate for OPD will be Rs.150/- per visit.

1.3 All OPD consultations/investigations will be on "Cash Payment Basis" by the employee concerned for self and his/her dependants.

1.4 Employees must produce his/her Identity Proof at the Hospital registration counter to avail the above benefit.

1.5. For dependants, a photo LD. documents showing relationship with the CSIR-CGCRI, Kolkata employee is required to be produced for availing the aforesaid facility. [Anyone of the items such as Voter card, Passport, Driving License, Aadhaar Card, ID card issued by any Govt./Semi-Govt./PSU etc will be treated as a valid document.]

1.6 A photocopy of the above documents as mentioned in Point 1.5 may be kept ready and produced at the Hospital registration counter as-and-when required/demanded.

1.7 B. P. Poddar Hospital & Medical Research Ltd., Kolkata will give DISCOUNT @15% for all Non-CGHS procedures/investigations to staff members/pensioners and dependants for OPD on prevailing hospital tariffs. This covers both OPD and IPD investigations/procedures.

1.8 B. P. Poddar Hospital & Medical Research Ltd., Kolkata will provide X-Ray, CT Scan, MRI Scan, USG etc films free of cost when the patient had undergone the above procedures.

1.9. No registration charges, Service Charges, Medical record charges shall be paid to the hospital.

1.10 Day-Care room rent (6-8 hours) will be Rs.500/-

2. IN-PATIENT DEPARTMENT (IPD)-REGULAR STAFF:

2.1 All staff members and their valid dependent family members may avail IN-PATIENT DEPARTMENT (IPD) medical treatment/procedures in B. P. Poddar Hospital & Medical Research, Kolkata on "**CASHLESS CREDIT MODE**" at CGHS-NABH-2021 accredited rates for Kolkata.

2.2 For availing cashless IPD treatment the concerned CSIR-CGCRI, Kolkata employee will have to make an application in the requisite format addresses to the Director, CSIR-CGCRI, Kolkata and submit the same to the Section officer (Bill) for issuance of an authorization letter. In case the hospitalization in odd hours and weekly offs/holidays, the authorization letter will be issued in the next working day on receipt of the request letter from the concerned employee.

2.3 In case of "Emergency", the hospital will not refuse admittance.

2.4 No Advance payment, service charge, Medical record charges should be made to the Hospital.

2.5 If the rate of any item/test is lower than that of CGHS ceiling rate B. P. Poddar Hospital, Kolkata will charge the lower rate.

2.6 The Indoor doctor consultation charges will be Rs.300/-per visit.

2.7 B. P. Poddar Hospital & Medical Research, Kolkata will give DISCOUNT @15% for all Non-CGHS procedures/investigations to staff members and dependants for OPD on prevailing hospital tariffs.

2.8 B. P. Poddar Hospital & Medical Research Ltd., Kolkata will provide X-Ray, CT Scan, MRI Scan, USG etc films free of cost when the patient had under the above procedures.

2.9 B. P. Poddar Hospital & Medical Research Ltd., Kolkata shall charges 50% less in the 2nd operation procedure when the patient has undergone 2(two) operations in the same in-patient stay duration.

3.FOR PENSIONERS [OPD TREATMENT]

3.1 Pensioners and their valid dependants may avail OPD treatments, including investigation, Day Care treatments in B.P. Poddar Hospital & Medical Research Ltd., Kolkata at CGHS NABH accredited rates-2021 for Kolkata, extra rates as updated on 03.05.2021 for both procedures and investigations on '**SELF PAYMENT BASIS**'

3.2 The consultation rate for OPD will be Rs.150/- per visit.

3.3 All OPD consultations/investigations will be on "Cash Payment Basis" by the pensioner concerned for self and his/her dependants.

3.4 Pensioners must produce his/her Medical Identity Card at the Hospital registration counter to avail the above benefit.

3.5. For dependants, a photo LD. documents showing relationship with the CSIR-CGCRI, Kolkata pensioner is required to be produced for availing the aforesaid facility. [Anyone of the items such as Voter card, Passport, Driving License, Aadhaar Card, ID card issued by any Govt./Semi-Govt./PSU etc will be treated as a valid document.]

3.6 There shall be no reimbursement of availing OPD treatments. However Phaco+IOL implantation, Dialysis, Chemotherapy treatments shall be reimbursable as per CGHS NABH rates for Kolkata-2021 (which falls under DAY-CARE CATEGORY). Day-Care room rent (6-8 hours) will be Rs.500/-



3.7 B. P. Poddar Hospital & Medical Research Ltd., Kolkata will give DISCOUNT @15% for all Non-CGHS procedures/investigations to staff members/pensioners and dependants for OPD on prevailing hospital tariffs. This covers both OPD and IPD investigations/procedures.

3.8 B. P. Poddar Hospital & Medical Research Ltd., Kolkata will provide X-Ray, CT Scan, MRI Scan, USG etc films free of cost when the patient had undergone the above procedures.

3.9 No registration charges, Service Charges, Medical record charges shall be paid to the hospital.

4. IN-PATIENT DEPARTMENT (IPD)-PENSIONER:

4.1 All pensioners and their valid dependent family members may avail IN-PATIENT DEPARTMENT (IPD) medical treatment/procedures in B. P. Poddar Hospital & Medical Research, Kolkata on "CASHLESS CREDIT MODE" at CGHS-NABH-2021 accredited rates for Kolkata.

4.2 For availing cashless IPD treatment the concerned CSIR-CGCRI, Kolkata pensioner will have to make an application in the requisite format addresses to the Director ,CSIR-CGCRI, Kolkata and submit-the same to the Section officer (Bill) for issuance of an authorization letter. In case the hospitalization in odd hours and weekly offs/holidays, the authorization letter will be issued in the next working day on receipt of the request letter from the concerned pensioner.

4.3 In case of "Emergency", the hospital will not refuse admittance.

4.4 No Advance payment, service charge, Medical record charges should be made to the Hospital.

4.5 If the rate of any item/test is lower than that of CGHS ceiling rate B. P. Poddar Hospital, Kolkata will charge the lower rate.

4.6 The Indoor doctor consultation charges will be Rs.300/-per visit.

4.7 B. P. Poddar Hospital & Medical Research , Kolkata will give DISCOUNT @15% for all Non-CGHS procedures/investigations to the pensioners and dependants for OPD on prevailing hospital tariffs.

4.8 B. P. Poddar Hospital & Medical Research Ltd., Kolkata will provide X-Ray ,CT Scan, MRI Scan, USG etc films free of cost when the patient had under the above procedures.

4.9 B. P. Poddar Hospital & Medical Research Ltd., Kolkata shall charges 50% less in the 2nd operation procedure when the patient has undergone 2(two) operations in the same in-patient stay duration.

4.10 *The pensioner will have to pay-up the In-admissible amount over-and-above the notified CGHS-NABH rates 2021 for Kolkata, extra rates as updated on 03.05.2021 /Ceiling rates and as amended by Govt. of India from time-to-time. CSIR-CGCRI,Kolkata will not be liable to pay any amount thereof to the hospital , for non-recovery of inadmissible amount from the pensioner/pensioner's patient party before discharge from the hospital.*

- 02) The rates of artificial appliances for CSIR-CGCRI, Kolkata beneficiaries will be governed by CGHS O.M. No.S.11011/25/2014/CGHS(p) Govt. of India, Min. of Health & family Welfare dated 08.07.2014
- 03) B. P. Poddar Hospital & Medical Research Ltd., Kolkata will entertain prescription of CSIR-CGCRI Part Time medical Doctor and also other Private Doctor's prescription pertaining to CSIR-CGCRI, Kolkata staff/pensioners and their valid dependants for the purpose of pathological & diagnostic services and will charge CGHS-NABH rates-20 21 for Kolkata and extra rates as updated on 03.05.2021
- 04) B. P. Poddar Hospital & Medical Research Ltd., Kolkata will abide by all new/amended rates issued by CGHS/Govt. of India from time-to-time.
- 05) Ceiling Cardiac stent rates as per Order dated 13th February,2017 (published in Part II, Section 3, Sub Section (ii) of the Gazette of India Extraordinary) Government of India, Ministry of Chemicals and Fertilizers Department of Pharmaceuticals, National Pharmaceuticals Pricing Authority, New Delhi and further revised on 01st April,2017
