Warranty period will start from the date of successful completion of all contractual obligation.
- iv) Submission of "Bid Securing Declaration" as per CGCRI's tendered format is applicable and mandatory.
- v) There is no change in Payment Terms as mentioned in CGCRI's tender document.
- vi) Integrity Pact is not applicable in this case.
