

3.	Payment	The payment shall be made in Indian Rupees, as follows:  Net 100% payment by RTGS within 30 days from date of delivery of all ordered materials and acceptance of supply of all ordered items including completion of Installation, Commissioning & Demonstration of above items by firms and all contractual obligations to the entire satisfaction of the buyer.  Note:  All payments due under the Contract shall be paid after deduction of statutory levies at source (like ESIC, Income Tax, etc.), wherever applicable.
4.	Performance Security	The Supplier shall furnish Performance Security equivalent to 5% of the contract price i.e. for INR 32,509.00, valid till 60 days after the warranty period of 01 (one) year at the time of release of payment after completion of Installation, Commissioning and Acceptance Certificate issued by the Purchaser and fulfillment of all contractual obligations prescribed in Purchase Order.  The proceeds of the performance security shall be payable to the Purchaser as compensation for any loss resulting from the Supplier's failure to complete its obligations under the Contract.  The Performance security shall be in one of the following forms:  a) A Bank guarantee issued by a Nationalized/Scheduled bank located in India Or A Banker's cheque or Account Payee demand draft in favour of the purchaser.  The performance security will be discharged by the Purchaser and returned to the Supplier not later than 60 days following the date of completion of the Supplier's performance obligations, including any warranty obligations, without levy of any interest.

6.	Delivery period	The Supplier shall deliver the consignment within 80 (Eighty) days from the date of issue of Purchase Order.  Denial Clause (over and above levy of Liquidated Damage): any increase in statutory duties and/or upward rise in prices due to the PVC (Price Variation Clause) clause and/or any adverse fluctuation in foreign exchange are to be borne by the seller during the extended delivery period, while the purchaser reserves his right to get any benefit of a downward revisions in statutory duties, PVC and foreign exchange rate.
7,	Warranty	Comprehensive Warranty for 01(One) year from the date of installation date.

8.	Insurance	The Insurance in respect of goods to cover all risks upto final destination (CSIR-CGCRI, Kolkata) shall be borne by Supplier at its own costs.

All charges for Installation, Commissioning & Demonstration work are included in Purchase Order value.  Installation & Commissioning work to be completed within 20 days from the date of receipt of all ordered materials at this Institute.  Successful conduct and conclusion of the acceptance test for the installed goods shall also be the responsibility and at the cost of the Supplier.
10.	Training	Onsite training for 1 (one) working day for 3 (three) persons of CSIR-CGCRI during installation period.
11.	LD Clause	The penalty shall be at the rate of (0.5%) point five percent per week or subject to a maximum of (10%) ten percent of Order Value for late delivery and towards delay in Installation & Commissioning including all contractual obligations beyond contractual deadlines.
12.	Certificate for effecting payment	Firm will submit the Acceptance Certificate/Installation Certificate duly signed by the user of CSIR-CGCRI alongwith invoice.
